- 3. This trust shall have its registered office at No.207, Radhakrishnan Avenue, Medavakkam Main Road, (opp. To Rose Nagar), Nanmangalam, Chennal 600 129, in the first instance OR at any other convenient place so decided from time to time by the Trustees.
- 4. The objects of the trust are:
 - a) To open, run and continue a school for the education of boys and girls in arts and vocational pursuits and to develop character of the students as well as to educate them in physical culture.
 - b) To establish and maintain a boarding house for the students who receive education in the school.
 - c) To establish or run or assist in establishing or running libraries, resource centres, training centres, schools, museums, research institute cultural schools (i.e. music dance drama art etc.) as well as medical centres as well as other relief centres for general public utility.
 - d) To establish, maintain and run studentships, scholarships and render other kinds of aid to meritorious students including supply of books, stipends, medals and other incentives to study without any distinction as to caste, colour, race, creed or sex.
 - e) To permit the use of movable or immovable properties and assets of the Trust without profit motive by institutions or trusts whose objects are similar to the objects of the Trust.
 - f) To conduct or assist in conducting activities of arts, music dance, drama, literature, scientific and charitable nature to all or any of the objects of the Trust and for the achievement of the objects mentioned herein.

- 5. Declaration of the Trust: The Founder has delivered their moveable assets consisting of cash amounting to Rs. 1000/- (Rupees one Thousand only) to the Trustees to hold the same unto and to the use the Trustees upon trust and with, under and subject to the power and provisions herein contained.
- 6. Property of the Trust: The Property of the Trust shall include the following sums:
 - (a) Such contributions, donations, endowments, settlements made by the public, government, institutions etc., for the purpose of advancement of aims and objects of the Trust
- 7. Power and Duties of the Trustees: -
 - (a) The Trustees shall put up suitable buildings or other constructions to maintain alter and equip them suitably with machinery and other things and to the discretion of the Trustees to permit their use on lease or license to institutions or organizations devoted to the objects which are similar to those of the Trust.
 - (b) The Trustees shall employ such staff as they think necessary for giving arts and crafts education to the students as well as to develop their physique and character on such salaries as they think fit and replace them whenever they think necessary. The Trustees shall also employ and remove other servants which they consider necessary for the purpose.
 - (c) Out of the income of the trust fund the Trustees shall defray the expenses for running the school and Boarding House as aforesald and expenses for erecting building of the school and Boarding House, but if the income is insufficient for and that purpose the Trustee may use such portion of the corpus of the Trust fund as may be necessary.

- (d) The Trustees shall have the power to borrow money on the security of the trust property and to alienate the trust property for necessary purpose, with the prior approval of the Director of Income Tax (exemptions).
- (e) The Trustees may invest the surplus fund in their hands in such securities as they deem fit, in accordance with Section 11 (5) of the Income Tax Act.
- 8. The Founder shall always nominate the trustees.
- 9. If any of the Trustees becomes bankrupt or found guilty by Court of an offence involving moral turpitude or become insolvent or remains absent from India for a period of three months or resigns from his post or otherwise incapacitated physically, the remaining trustees with the consent of the Founder appoint this substitute.
- 10.In case there is a difference of opinion between the Trustees the decision of the majority of the Trustees relating to the trust shall be binding and be effectual and shall be carried out.
- 11.In case of failure of the trust for want of its objects or trust having become impossible of performance, the trustees shall move the Court for applying the remaining trust fund for similar objects.
- 12. The Trustees shall in no case be liable for any loss to the loss to the trust estate unless the trustees are guilty of fraud.
- 13. This is a public registered trust, the property of the trust shall in no case revert to the Founder of his descendants or to any other person.
- 14.No part of the trust fund, either the corpus or the income therefrom, shall be utilized for any object other than that of the trust hereby created.

- 15. That the Trust Fund may be augmented by the income from the initial fund and also by donation and other contributions from time to time.
- 16. That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the trust.
- 17. That for the furtherance of the objects of the trusts, the trustees shall have the following powers:
 - (a) To accept any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, with or without conditions.
 - (b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations hereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
 - (c) To convert and deal with the trust property and /or any investments for the time being, with the prior approval of the Director of Income Tax (Exemptions).
 - (d) To open account in the name of the Trust, Trustees and/ or Institutions run/conducted by the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
 - (e) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.

- (f) To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.
- (g) To make, vary alter or modify schemes, rules and regulation for carrying out the objects of the Trust and for the management of the affairs thereof and /or running any institution in furtherance of the objects of the Trust and otherwise for giving effects to the objects of the Trust, with the prior approval of the Director of Income Tax (exemptions).
- (h) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
- (i) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of nay or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.

- 18. The Trustees will not be entitled to receive any remuneration but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
- 19. The number of the Trustees shall not be less than two and more than seven. If the number of the Trustees shall fall below two, the trustees shall not, except for the purposes of filling any vacancy, act so long number is below the said minimum.
- 20. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
- 21. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations: -
 - (a) Two Trustees shall form a quorum for a meeting of the Trustees
 - (b) All matters will be decided mutually by the Trustees
 - (c) Resolution passed without any meeting of the Trustees but by circulation thereof an evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of the trustees.
- 22. The accounting year of the Trust shall be the financial year ending on 31st March every year.
- 23. The Trust and the Trust funds shall be and irrevocable for all times.
- 24. The office of the Trust shall be situated at Nanmangalam, Chennal unless changed by the Trustees by two thirds majority.



- 25.It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.
- 26.In case of winding up /dissolution , the net funds would be transferred to Institutions having similar objects and enjoying exemption Under Section 11 and 80G of the Income Tax Act1961.
- 27.Any amendment to the instrument would be carried only with the approval of Director of Income Tax (Exemptions).
- 28. The activities would be confined to the territory of India.
- 29. The activities would be purely of charitable nature and not motivated for profit.
- 30. The funds of the institution would be utilized only towards the objects and no portion of it would be distributed in any manner to the trustees or persons defined in Section 13(1) (c) of the Income Tax Act, 1961.
- 31. The funds of the institution would be invested as per section 11 (5) of the Income Tax Act, 1961.
- 32. The accounts would be maintained regularly and would be audited by a Chartered Accountant (Explanation to Section 288 (2) of the Income Tax Act, 1961).
- 33. The funds of the institution would not be applied for any religious purposes or given to religious institutions.
- 34.Acquisition / alienation of immovable property shall be done with prior approval of the Director of Income Tax (Exemptions) Chennai.


